Sale escrow fees are calculated per side (Buyer & Seller) with a \$250-\$350 base plus \$2.50 to \$3.50 per thousand of the selling price. Additional fees for processing, notary and document preparation vary from \$100 to \$300 or more.

PACIFIC FORESIGHT FINANCIAL CORP., E MORTGAGE CAPITAL, EZ FUNDINGS AND ACADEMY MORTGAGE CORP.: Rates and fees are based on the type and amount of the loan and can range from 0 to 3% or more of the loan amount.
